

AE.BET PROMOTIONAL GIVEAWAY GAME

This Promotion is conducted by Accel Entertainment Gaming, LLC ("Accel"), located at 140 Tower Drive, Burr Ridge, IL, 60527, The Nora Bar ("Location"), located at 110 South St. Nora IL 61059 (address), together the "Sponsors."

Promotion is only open to legal residents of the States of Illinois, Indiana, Iowa, Kentucky, Michigan, Minnesota, Missouri, Tennessee, and Wisconsin who are twenty-one (21) years of age or older and have a valid email address at the time and date of entry ("Participants"). To participate and to redeem any prize associated with Promotion, Participants must be eligible to both sign up for and wager through an AE.BET Sportsbook account ("AE.Bet Account").
